

Since then, multifamily housing starts have remained generally flat largely as a result of federal policies such as HOPE VI and the push Housing starts for single family and multifamily buildings with 5 or more dwellings were both good indicators of recessions and recoveries until for homeownership, affecting the production of multifamily housing in the last two decades.
